In exercise of the authority conferred under provision 4(1) of the Assam Education(Provincialisation of services of Teachers and re-organisation of Educational Institutions)Act,2017 & Amended Act, 2018 and in pursuance of the Govt. sanctioned order No.AHE.1010/2019/Pt/49, dtd 01/02/2021 and No. AHE. 490/2020/25 dtd. 01/02/2021 the services of the following employees of UPENDRA NATH BRAHMA COLLEGE, KAJALGAON, CHIRANG, district CHIRANG have been provincialised and they are now employees of the State Government with effect from 01-01-2021 with the following terms and conditions as mentioned below:

The employees whose services have been provincialized under this Act. shall get pay and such emoluments as per norms of the State Govt. or as per provisions contained in this Act. w.e.f. 01.01.2021 and they will be treated as fresh appointee. They cannot claim any benefit whatsoever in respect of past services rendered by them before provincialization and in respect of pension, they shall be governed by the NPS applicable to the State Govt. employees of the corresponding rank.

They are also entitled to draw the minimum scale of pay and allowances/fixed salary mentioned against their name as admissible under rules and as per provision under section 8(2&3) of the said Acts with effect from 01-01-2021.
